

Water Conservation Rebate Application

Water Conservation Rebates & Incentives			
Rainwater Cistern (Rain Barrel): Requires the installation of a minimum 100-gallon capacity rain barrel or engineered cistern. Rainwater storage systems may not be interconnected with the City potable water system. Requires receipts of purchase, and photos of installation. Applicants must contact Public Works for	\$500.00 maximum award		
 guidelines prior to installation of the system. 50-65 gallon capacity rain barrel 75 gallon and larger capacity rain barrel 	\$0.50 per gallon of storage \$1.00 per gallon of storage		
Rain Garden (Passive Rainwater Harvesting): A minimum of 50 sq. ft. must be installed with a minimum of 400 sq. ft. of stormwater redirected from the roof. Only native plants may be planted in rain garden, but catchment may also be rock lined. Rebate is for basin footprint. Applicants must contact Public Works for guidelines prior to installation of the system.	\$500.00 maximum award \$3.00 per square foot of basin footprint		
Turf Removal: Requires conversion from irrigated turf grass to water saving landscaping, and if irrigated, installation of an automatic water timer, backflow prevention device, and drip or similar system. Minimum turf removal areas are 200 square feet for residential and 1,000 square feet for non-residential. Requires receipts of purchase, and before and after photos. Applicants must contact Public Works for guidelines prior to removal of turf.	\$1.00 per square foot		
WaterSense Labeled Smart Irrigation Timer: Must use local weather data or soil moisture sensors to limit unnecessary outdoor watering, must be easy to use, and be EPA WaterSense approved.	\$75.00		
Ultra-Efficient Washing Machine: Washer must be on the City of Prescott Clothes Washer Qualifying Product List at the time of purchase to qualify.	\$200.00		
 Toilets: Replacement units must use one or a combination of the following: 1.0 gallon per single flush toilet 1.0/1.28 gallons per dual flush toilet 1.28 gallons per single flush toilet Receipts required. 	\$150.00 \$125.00 \$100.00		
Water Customers on Septic Systems: Additional toilet and/or washing machine replacement incentive.	\$50.00		
Commercial Urinals: Must be an EPA approved alternative flushless design, flush once at a specified interval, or 0.125 gallons per flush.	\$100.00		
Hot Water Recirculation System: Photos and receipt required.	\$150.00

Water Conservation Rebate Program (P.C.C. 3-10-8)

Intent

To encourage residents and businesses to conserve water, the following conservation rebate program has been established. This program applies to the purchase and installation of devices to retrofit plumbing fixtures with high rates of flow, and to limit outdoor water use for landscaping purposes.

Eligibility

Open to all City of Prescott water utility customers. Please follow all rules and regulations of the program in order to receive a credit on your utility bill.

Other Rules and Information

- Each item is a one-time award for the property, fixture or equipment as indicated, subject to City review and approval.
- All incentive awards require and are subject to the submittal of complete applications and determination of eligibility and qualifications by the City. Incomplete applications are subject to return.
- Applications will only be accepted from the current property owner(s) of record.
- The incentive program is provided on a first come, first serve basis, subject to the availability of budgeted funding.
- Total incentives granted for a property shall be limited to \$2,500.00.
- Rebate awards will be credited on utility bills for the applicable properties within three billing cycles after approval.
- City is not responsible for selection, installation, or performance of any water saving device.
