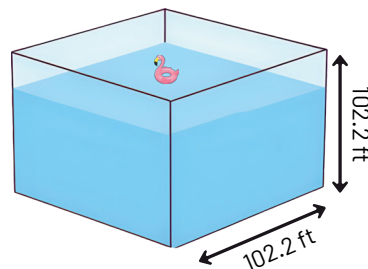
Water Conservation Rebates & Incentives- Indoors

<p>Residential or Commercial Manual Toilets</p> <p>Rebate is for replacement of existing toilets. Toilets being replaced must use 1.6 gallons per flush or more. Commercial manual Flush-o-meter toilets qualify for the same rebates as residential toilets. Photo of toilet being replaced showing flush volume is required (found inside tank or behind lid).</p> <ul style="list-style-type: none"> • 1.0 gallon per single flush toilet • 1.0/1.28 gallons per dual flush toilet • 1.28 gallons per single flush toilet 	<p>\$150</p> <p>\$125</p> <p>\$100</p>
<p>Commercial Urinals and Automatic Flush-o-Meter Toilets</p> <p>Rebate is for replacement of existing toilets/urinals. Toilets being replaced must use 1.6 gallons per flush or more. Urinals being replaced must use more than 1.25 gallons per flush to qualify. Photo of toilet/urinal being replaced showing flush volume is required (found inside tank, behind lid or on top of urinal).</p> <ul style="list-style-type: none"> • Urinal: WaterSense 0.125 gallons per flush or less • Urinal: Waterless • Automatic Flush-o-Meter 1.1-1.28 gallons per flush • Automatic Flush-o-Meter 1.0 gallon per flush or less 	<p>\$100</p> <p>\$225</p> <p>\$200</p> <p>\$225</p>

Water Conservation Rebates & Incentives- Outdoors

<p>Rainwater Barrels/Cisterns: Rebate is for rainwater collection only. Collapsible, pvc-type rain barrels and cisterns do not qualify. Rainwater storage systems may not be interconnected with the City potable water system. Requires receipts of purchase, and photos of installed rain barrels or cisterns. \$500.00 maximum award. <i>Cistern refers to a storage unit with a 100 gallon capacity or more.</i> Contact the water conservation specialist for guidelines prior to installation.</p> <ul style="list-style-type: none"> • 50-74 gallon capacity rain barrel • 75 gallon and larger capacity rain barrel or cistern 	<p>\$500.00 maximum award</p> <p>\$0.50 per gallon storage \$1.00 per gallon storage</p>
<p>Rain Garden (passive): A minimum of 50 sq ft must be installed. A minimum of 400 sq ft of stormwater must be redirected from a roof. Only low water use, non-invasive and native plants may be planted in a rain garden. Catchments may be rock lined. Rebate is for basin footprint. <i>Applicants must complete a <u>pre-application</u>* prior to starting the project to qualify for a rain garden rebate.</i></p>	<p>\$500.00 maximum award</p> <p>\$3.00 per sq ft of basin footprint</p>
<p>Turf Replacement: Requires conversion from maintained, actively irrigated turf grass to drought tolerant, low water use plants or xeriscape landscaping. If conversion area is irrigated, an EPA WaterSense labeled Smart timer/controller, backflow prevention device, and drip or similar system is required. <i>Applicants must complete a <u>pre-application</u>* prior to starting the project to qualify for a turf replacement rebate.</i> Requires receipts of purchases/installation invoices and before and after photos.</p>	<p>\$1.00 per sq ft</p> <p>\$1.25 per sq ft for areas planted with drought tolerant, low water use plants</p>
<p>WaterSense Labeled Smart Irrigation Timer/Controller: Must be set up to use local weather data or soil moisture sensors. Requires receipts/invoices and photos of installed unit and account showing active weather feature.</p>	<p>\$75.00</p>

ABOUT THE INCENTIVE PROGRAM

The City of Prescott's WaterSmart™ conservation incentive program is designed to encourage residents and businesses to conserve water. This program applies to the purchase and installation of devices to retrofit plumbing fixtures and appliances with high volume use, and to reducing outdoor water use for landscaping purposes.

Whether you do the work yourself or hire a contractor, City of Prescott water utility customers collectively save millions of gallons of water a year and thousands of dollars by choosing to make WaterSmart upgrades indoors and outside. (P.C.C. 3-10-8)

ELIGIBILITY

Open to all City of Prescott water utility customers.
Program terms, conditions and regulations must be followed in order to qualify.

TERMS AND CONDITIONS

- Applicant must be the property owner of record. Non-residential property lease holders without water accounts may submit a consent form which has been completed by the City of Prescott property utility account holder to qualify.
- All incentive awards require and are subject to the submittal of complete applications and determination of eligibility and qualification by the City. Incomplete applications are subject to return. Please contact the City if you need assistance.
- Each item is a one-time award for the property, fixture or equipment as indicated, subject to City review and approval.
- The incentive program is provided on a first come, first serve basis, subject to the availability of budgeted funding. Policy requirements are subject to updates.
- Rebate applications must be submitted no later than 1 year after the purchase of the eligible product. For turf replacement and rain gardens, upon approval of eligibility, customer has 6 months for completion and application submittal.
- Total incentives granted for a residential property shall be limited to \$2,500. Total incentives granted for a commercial, multifamily residential property or HOA shall be limited to \$5000.
- Turf replacement and rain gardens require a pre-application and preapproval to qualify for a rebate.
- Incentive awards will be provided within 90 days after approval.
- The City of Prescott is not responsible for selection, installation, or performance of any water saving device or landscaping rebate project.
- Applicants who expect to receive rebates totaling more than \$2000 in the current calendar year must submit a W9 form with their rebate application.
